The regular meeting of the Grand Traverse County Department of Health and Human Services Board was called to order at 1:00 pm by Board Chair Cecil McNally at the Garfield Township Hall.

First Public Comment - None

<u>Approval of Agenda</u> – Chair McNally asked if there were additions, changes or corrections to the agenda. Motion was made by Marois to approve the Agenda with presented changes, seconded by LaPointe and carried unanimously.

<u>Draft DHHS Board Rules of Order</u> – The board agreed to take more time to review the new document that was drafted off of the Grand Traverse County Rules of Order. Marois requested for it to be brought back to the next meeting for approval.

<u>GT County Resolution</u> – LaPointe had requested for County Commissioner Penny Morris to share a copy of the county resolution that was approved by the Board of Commissioners to have the DHHS Board record their meetings. County Commissioner Board Chair, Rob Hentschel, attended the meeting for Morris and stated a copy of the resolution could be requested by County Administration or through himself. LaPointe said he would follow-up.

<u>County Liaison Report</u> – County Board Commissioner Rob Hentschel updated the board on county Opioid funding and Community Mental Health on behalf of County Commissioner Penny Morris who was unable to attend.

General Discussion

<u>Food services</u> - Marois requested an update on food services. Coleman shared more cooks and dietary aids have been hired in the last month with a total of 66 interviews. Upper management jobs have yet to be filled. Coleman stated the residents report that they are happy with the new service. President Patrick Johnson and founder Dan Bowden will be presenting at the May 25 board meeting. LaPointe shared that he will be attending two out of the four resident council meetings in May. Marois shared a complaint she heard about a resident not receiving a meal early enough. Coleman stated she would personally look into it and explained meal times are delivered within a specific time period for each pavilion and will check the logs.

<u>Volunteering</u> – The board discussed recruitment of volunteers and requested to meet Volunteer Coordinator, Clayton Wagatha in the near future. Coleman reviewed what volunteers have

been able to do now that restrictions have been lifted. LaPointe noted he would like to see the volunteers not only help with the concerts but also with daily needs for the residents.

Financial update - Dood gave a financial update and answered board member questions on census and funding.
